## Amendment to Articles of Incorporation Of Southern United Neighborhoods

The undersigned, acting pursuant to the Nonprofit Corporation Law of the State of Louisiana hereby adopts the following Articles of Incorporation.

1. The name of the nonprofit corporation is "Southern United Neighborhoods."
2. This corporation is organized exclusively within the meaning of Section 501©3 of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, particularly for purposes of receiving and administrating funds and property for charitable and educational purposes in such manner as will best promote the mission of the corporation as set forth in the corporation's Bylaws; provided that in carrying out foregoing purposes and to the extent permitted by Code Section 501©3, the corporation is authorized to engage in any lawful activity incidental to such purposes for which corporations may be formed under the Louisiana Nonprofit Corporation Law. Notwithstanding any other provision of these articles, this corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Code Section 501©3 or corresponding section of any future federal tax code.
3. This corporation is a nonprofit corporation organized on a non-stock basis.
4. The duration of the corporation shall be perpetual.
5. The location and municipal address of the registered office of this corporation is 827 Tupelo Street New Orleans, LA 70117.
6. The name and address of the registered agent of this corporation is: Vanessa Johnson 827 Tupelo Street, New Orleans, LA, 70117.
7. The corporation shall have no members.
8. The initial board of directors will consist of M.D.R. Butler, whose address is 3046 Burgundy New Orleans, LA 70117 and Vincent Copper 6422 N. Derbigny New Orleans, LA 70117.
9. Distribution of Earnings and Assets: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the corporate purposes set out herein.
10. Upon DISSOLUTION of the corporation, its assets shall be distributed according to decisions made by its board of directors, as long as said distributions are made to one or more exempt purposes within the meaning of section 501c3 of the Internal Revenue Code, or corresponding

section of any future federal tax code, or shall be distributed to the federal government, or to a state of local government for a public purpose.

The amendment(s) have been adopted by unanimous consent of the board of directors at the meeting held on the 16<sup>th</sup> of March, 2010.
